## LONGINES GRAN PREMIO LATINOAMERICANO AND LONGINES CUP 2019 AT CLUB HÍPICO DE SANTIAGO, CHILE

OSAF is proud to announce the date and conditions for the 35th edition of this Grand Prix

**DATE: Sunday, 10th of March, 2019**  
**CONDITIONS: 3 UP**  
**DISTANCE: 2000 meters**  
**TRACK: turf**  
**PRIZE: USD 500,000.-**  
**FIELD SIZE: 18 competitors**

The race will develop clockwise, that is to say to the right hand side.

**Competitors:** Colts/horses and fillies/mares 3 years old and older, nominated by OSAF member Jockey Clubs or racecourses, and extra-classified horses coming from any country, who may have applied according to the provisions set by the Rules of Longines Gran Premio Latinoamericano, and subject to the approval of OSAF Board.

### **IMPORTANT:**

- Any horse who may have resulted positive for doping (forbidden substances) on the 6 (six) months prior to the running of LGPL or Longines Cup will not be eligible for entering any of these competitions.
- **Jockey doping controls:** During the race meeting, any jockey competing in these competitions may be tested for doping or alcohol test. According to Article 269 of the Chilean Racing Regulations, and for the purpose of these races, any findings of the following substances will be considered doping: Cocaine, coca paste and marijuana.
- **Horses Doping Control:** the samples of the competitors which finish in the first 5 positions in either Longines Gran Premio Latinoamericano and Longines Cup will be shipped to be tested for doping in one of the 5 IFHA reference laboratories.

**During the next few days, the Booklet of full conditions for Longines Gran Premio Latinoamericano and Longines Cup will be released, featuring all the local contact details for the information of the contestants. It will be circulated by mailing list and published in OSAF web and social media.**

## **SPECIAL CONSIDERATIONS OF THE RULES OF LONGINES GRAN PREMIO LATINOAMERICANO, FOR EXTRA-CLASSIFIED RUNNERS**

- **Deadline for pre-entry of Extra-classified applicants:** Monday, 10th of December 2018.
- **Pre-entry fee for Extra-classified applicants :** USD 1.000.-
- **Entry fee once the Extra-classified applicants are ratified** to compete in LGPL 2019: USD 25.000.- (minus the pre-entry fee)
- **Applications for Extra-classified runners shall be received with no exception by email, before Monday 10th of December at 18:00** (Argentine time) accompanied with the payment slip of the pre-entry fee, at OSAF secretariat email address ([skorembilit@osafweb.com.ar](mailto:skorembilit@osafweb.com.ar)) and OSAF CEO's address ([obertoletti@osafweb.com.ar](mailto:obertoletti@osafweb.com.ar)). **The names of the Extra-classified runners ratified to enter and run this edition shall be disclosed by mid January 2019.**

### **Extra-classified runners:**

Any owner may present their horse to run the Longines Gran Premio Latinoamericano, having been met the following requirements:

- a. An official application letter shall be submitted to OSAF Secretary/CEO ([skorembilit@osafweb.com.ar](mailto:skorembilit@osafweb.com.ar) / [obertoletti@osafweb.com.ar](mailto:obertoletti@osafweb.com.ar) ), addressed to OSAF Board, providing the name of the relevant Thoroughbred, 90 days prior to the running of the Grand Prix;
- b. OSAF Board shall decide upon the application within the 60 days prior to the running of the Grand Prix, subject to the starters quota and taking into priority the minimum runners quota corresponding to the member countries.
- c. Once approved the application, and in order to make effective the inscription to run the Grand Prix, the entry fee shall be paid no less than 30 days prior to the date of the race.
- d. The extra-classified applicants shall be charged with a pre-entry fee of USD 1,000.- which in the case of being ratified as runners shall be deducted from the cost of the entry fee ( USD 25,000.-)
- e. The entry fee shall be reimbursed to any runner upon their impossibility to travel to run the race, regardless of the fact that they may have been ratified, as long as the notification of the impossibility to run allows for another applicant to fill in the vacant quota and make the corresponding payment. Such entry fee shall be reimbursed to the scratched runner once the entry payment from the new contestant is fully covered.
- f. Horses freights, as well as jockey, trainer and stable assistant transfers costs shall be afforded by the owner, while the lodging at destination shall be afforded by the host racecourse.
- g. Any owner to submit applications for more than 1 horse to be eligible as extra-classified runner, shall pay 1 pre-entry fee for each of those horses. Should any of his applicants become ratified as a runner, the value of only 1 pre-entry fee shall be deducted from the total entry fee value, corresponding to the relevant ratified horse.

## SECOND INTERNATIONAL RACE: LONGINES CUP CARLOS CAMPINO (G2)

For the third consecutive year, OSAF and LONGINES support the international race meeting of LGPL through a second International Pattern race, with the purpose of motivating the participation of as many runners from abroad as possible, as a means of promoting international movement of horses within the region.

The quota for competitors from countries other than Chile represents a half of the starter.

**CONDITION: Filles and mares, 3 up**

**DISTANCE: 1800 m**

**TRACK: turf**

**PRIZE: USD 73.270.- (includes OSAF Prize of USD 54.000.-)**
